- c. Director of Curriculum and Instruction Ms. Bliss shared a plan to offer an elementary summer school program again this year with a focus on literacy skills. The nineteen-day program will be housed at Randall School with Mr. Kostuk as principal.
- d. Superintendent Mr. Hoose read a response letter from Senator Seward. He distributed a handout for review regarding a request to name the CJSHS wrestling room. There will be discussion at the next meeting.
